Dear Student:

Regulations and policies do not permit the release of student, spouse, or parental financial aid information without the consent of the student, spouse, and parent(s). This means that Financial Aid Office staff cannot discuss with anyone, including yourself, specific parental or spousal information provided without your parent's or spouse's written consent. It also means that our staff cannot discuss with anyone, including your parents or spouse, specific student information provided by you without your written consent.

The "Consent for Release of Information" form on the reverse of this letter is being provided to you if you want to authorize release of your financial aid information to another person(s). In PART I, you may indicate whom you would like to have access to your financial aid information. In PART II, your parents or spouse may indicate whom they would like to have access to their information which was provided as part of your financial aid application.

Inquiries by telephone pose a particular problem in maintaining the privacy of your financial aid status. Therefore, only general questions can be handled over the telephone unless you have a Personal Identification Code (PIC) on file with our office. The PIC established by the student (submitted on the Data Sheet, page 2, #7) must be provided by the student or the person named in Part II of this form when inquiring by phone to obtain more than general information. This procedure will permit us to comply with federal law and maintain the confidentiality of your financial aid status.
