



2009-2010 APPLICATION FOR SCHOLARSHIP

Purpose: To provide scholarships to students currently enrolled in an Associate's or Bachelor's Degree program majoring in Accounting, Finance or Economics in a San Diego County college or university.

Award Components:

1. One (1) \$1,000 scholarship will be awarded to a student enrolled in a Bachelor's Degree program.
2. Two (2) \$500 scholarships will be awarded to students enrolled in an Associate's Degree program.
3. Scholarship recipients will receive a free one-year student membership in the San Diego Chapter of ASWA.
4. Award selections will be made by the Board of Directors of the ASWA, San Diego Chapter. The scholarship recipient will be awarded 50% of the total scholarship upon acceptance of the award with proof of current enrollment and 50% upon successful completion of the current semester.

Criteria:

1. Applicants for a Bachelor's Degree scholarship must be a Junior or Senior enrolled in Bachelor's Degree program in Accounting, Finance, or Economics at a San Diego County college.
2. Applicants for an Associate's Degree scholarship must be entering second year of Associate's Degree program in Accounting, Finance or Economics at a San Diego County college.
3. Applicant must be majoring in accounting or related field of study.
4. Applicant must be enrolled in a minimum of six units.
5. Applicant must have a minimum cumulative grade point average of 3.0 out of 4.0.

Applicant Must Submit:

1. Completed scholarship application form
 - a. Incomplete applications will not be processed.
 - b. Application form also available on our website: www.aswasandiego.org
2. Personal Statement
 - a. Provide a brief explanation of career goals and biographical (background) information.
3. College transcript(s) from current college/ university.
4. Current copy of resume.
