Repeating a course after receiving a "W" does not count toward the single repetition rule.</li> <li>Sciences must be 4 or more units and include a lab component.</li> <li>Final grades must be posted on transcripts</li> </ul>
<p>Category= GPA: Non- Sciences</p> <p>“Fixed Set” minimum GPA 2.75 (English, Speech/Communication, Psychology/Sociology); Max points= 15</p> <p>GPA = 4.0            11 points  GPA = 3.5 – 3.99    9 points  GPA = 3.0 – 3.49    7 points  GPA = 2.75 – 2.99   5 points</p> <p>Completion of Transfer Coursework: Max 4 points</p> <ul style="list-style-type: none"> <li>College level statistics course= 2 points</li> <li>MiraCosta CHEM 112 (5 units; 3 lec, 2 lab) or its equivalent = 2 points</li> </ul>	15 points max	<ul style="list-style-type: none"> <li>MiraCosta fixed set required courses (overall GPA 2.75): Completion of 4 semester units of Composition and Reading (ENGL 100) or its equivalent; Speech/Communication &amp; Psychology/Sociology</li> <li>MiraCosta transfer coursework to receive points: Completion of CHEM 112 Introductory General, Organic, and Biological Chemistry: For Allied Health Majors (5 units; 3 lec, 2 lab) or its equivalent; college level statistics course</li> <li>All grades for the non-science courses must be “C” or better</li> <li>Final grades must be posted on transcript</li> </ul>
<p>Category= Assessment/Readiness Test Results</p> <p>Composite score on FIRST ATTEMPT of Test of Essential Academic Skills (ATI TEAS):</p> <p>95-100% = 30 points  90-94 % = 28 points  85-89% = 26 points  80-84% = 24 points  75-79% = 22 points  70-74% = 20 points  65-69% = 16 points  62-64% = 13 points</p> <p>Less than 62% = 0</p>	30 points max	<ul style="list-style-type: none"> <li>To increase TEAS points, applicants can retest after 6 months after the date of 1st test attempt.</li> <li>If score is less than &lt; 62% on 1st attempt, applicants need to contact the program director to arrange a meeting to establish a remediation plan. Remediation plans developed by other nursing programs will not be accepted.</li> <li>When applying to the program, applicants are required to upload an unofficial TEAS score report with their online application. Additionally, an official TEAS score report is required to be sent from ATI to MiraCosta by February 15 (if applying in March) or by August 15 (if applying in September).</li> </ul>
<p>Category= Degrees/Work Experience/Certifications</p> <p>Academic degrees or diplomas, or relevant certificates held by an applicant.</p> <p>Documented relevant work or volunteer healthcare experience within the past 2 years (see REQUIRED DOCUMENTATION/INFORMATION column).</p>	15 points max	<ul style="list-style-type: none"> <li>AS/AA/BS/BA/MS/MA from a U.S. accredited institution on official transcript = 5 points</li> <li>Copy of current unencumbered Licensed Vocational Nurse (LVN) license= 7 points</li> <li>Copy of active Certified Nurse Assistant certification (excludes LVNs) = 5 points</li> <li>Copy of active Allied Health certification (excludes LVNs &amp; CNAs) = 2 points</li> <li>Relevant healthcare work within 2 years: 500-1040 hours= 2 points, ≥1041 hours = 5 points</li> <li>Relevant volunteer healthcare experience of minimum of 100 hours within 2 years= 1 point</li> <li>Corpsman experience/medic = 5 points</li> </ul> <p>Relevant work or volunteer experience documentation must include dates, total hours, title, and duties. It should be on official letterhead and signed by a company representative.</p>

<p>Category= Life Experiences</p> <p>Life experience or special circumstances of an applicant, including but not necessarily limited to, the following:</p> <ol style="list-style-type: none"> <li>a. Disabilities</li> <li>b. Low Family Income</li> <li>c. First generation in family to attend college</li> <li>d. Need to work during prerequisites.</li> <li>e. Disadvantaged, social or educational environment</li> <li>f. Difficult personal and family situations or circumstances</li> <li>g. Refugee or Veteran status</li> <li>h. Active duty/reservist</li> <li>i. Spouse of veteran or active duty/reservist service personnel</li> <li>j. Living in a medically underserved area or population (designated by federal Health Resources and Services Administration)</li> </ol>	<p>10 points max</p> <p>(2 points each up to a total of 10 points)</p>	<ol style="list-style-type: none"> <li>a. Documentation from Student Accessibility Services (SAS) or from a licensed provider.</li> <li>b. Documented copy of eligibility for financial aid: examples include Cal Grant, CalWORKS, California Community Colleges Promise, P Grant, Federal Pell Grant or EOPS, Guardian Scholars, TRiO (award letter or SURF award printout)</li> <li>c. Written statement from applicant</li> <li>d. Documentation from employer on company letterhead verifying dates of employment or a W2 or a paystub (hours worked must correlate with dates of prerequisite courses)</li> <li>e. Documented copy of eligibility for Extended Opportunity Programs and Services (EOPS)</li> <li>f. Statement from applicant of at least 250 words explaining background, situation or extenuating circumstances that occurred within past 2 years.</li> <li>g. Copy of card indicating refugee status or DD214.</li> <li>h. Letter from an HMC or higher stating applicant is serving honorably or copy of Military ID</li> <li>i. Copy of marriage certificate and copy of spouse's DD214 or military ID</li> <li>j. Screenshot of applicant address results after entering into federal <a href="#">Health Resources and Services Administration shortage areas tool</a>. Address entered in the tool must match address in SURF.</li> </ol>
<p>Category= Proficiency or advanced level coursework in languages other than English</p> <p>Documented proficiency or upper division coursework in languages other than English. Credit for languages other than English shall be received for languages identified by the Chancellor's Office.</p>	<p>5 points max</p>	<p>5 points total for the ability to communicate in languages other than English in the health care setting.
