  - 6.1.1 Yes = 10 Bonus Points (note if you certify that you are a Local Business Level I Entity, you are not entitled to receive Bonus Points under the next paragraph A Local Business Level I Entity may only receive a total of 15 Bonus Points under this paragraph 6.).
- 6.2 The local hire classification pertaining to Measure MM procurements for purposes of this Call for Pre-Qualification Applications defines "Local Business Level II Entity" as: "a business serving as a firm that has its principal headquarters or permanently staffed regional office located within San Diego County or within a 50 mile radius of the Northernmost point of Area 6 of the District, and has held a business license with one of the cities within this defined area for a minimum of three months."
  - 6.2.1 Yes = 10 Bonus Points (note if you certify that you are a Local Business Level II Entity, you are not entitled to receive Bonus Points under the above section A Local Business Level I Entity. A Level I Entity may only receive a total of 10 Bonus Points under 6.1.1 above).
- 6.3 Do 50% or more of your employees reside within "Local Business Level I or Level II" area as defined in 6.1 or 6.2 above?
  - 6.3.1 Yes = 10 Bonus Points
