Special note: All meetings are currently held in-person, however on September 13, 2022, California Governor Gavin Newsom signed California Assembly Bill 2449 (AB 2449) into law. This bill changes remote attendance rules under Ralph M. Brown Act's open meeting laws. With an effective date of January 1, 2023, AB 2449 imposes four periods of differing rules on remote access to, and member attendance of, local agency public meetings under the Ralph M. Brown Act (Brown Act). Further, a state of emergency is no longer in effect and so governing bodies will now meet in person with the possibility of approved remote attendance. The public may observe the meeting remotely or in person and offer public comment. A link for remote viewing or calling in is noted on the agenda.

2023-24 ASG Standing Rules

- 1. Members will wear their name tags at all ASG events (and meetings), or if participating in a virtual event, they will update their name and ASG role as their title (ex: update name on zoom to: "Name, ASG role").
- 2. Members will exercise respect and civility inside and outside of the Student Senate while being mindful of others speaking and sharing air time.
- 3. Members will limit their use of electronic devices in ASG meetings to the business of ASG, such as agendas or agenda attachments.
- 4. Attendance:
 - a. Members are allowed two total tardies/ two early departures (not present for <= 25% of a meeting). Members are allowed two total absences per semester (not present for > 25% of a meeting).

Discussion on how ASG can respond to issues that negatively impact students: Last meeting, ASG members asked questions about how the college responds to concerning speech on campus, how ASG can issue official statements on issues, and other similar topics. This time was for some education and discussion on speech on campus, and the policies and ethical considerations that affect the college, ASG, and individual students.
 - a. Members considered:
 - i. How can ASG respond to issues negatively impacting students?
 - ii. What can ASG note as impactful accomplishments?
 - iii. How can ASG be more effective and less performative?
 - 1. Suggestion: Pro-actively check in with the Black Student Union (BSU), Movimiento Estudiantil Chicanx de Aztlán



(MEChA), and Gender Sexuality Alliance (GSA) to learn what concerns they have and how they can be better supported.

- b. How can a college both protect free speech and promote an inclusive environment?
 - i. Consider how everyone has the right to speak, even if that speech is not something all individuals want to hear.
- c. Members considered what colleges can do:
 - i. Per the ACLU:
 - 1. Speak out
 - 2. Educate
 - 3. Promote dialogue
 - 4. Promote diversity
- d. Members considered: What is harmful?
 - i. Who gets to decide?
 - ii. What are the harms and needs of our campus community?
 - 1. Ex. Some campus programs or student organizations have issues with the increased police presence on campus.
- e. Members considered possible scenarios and asked:
 - i. How can counter speech be used to address hateful speech? And when does counter speech only serve to give more attention to hateful speech?

How can we respond to harm?


Discussing the college's role and ASG's potential role in responding to issues of harm and free speech

How can colleges limit speech?

Regulate time, place, and manner

"Persons using and/or distributing material in the areas shall not impede the progress of passersby, nor shall they force passersby to take material."

"Persons using the areas shall not use any means of amplification that creates a noise or diversion that disturbs the orderly conduct of the campus or classes."

These must be subject matter and viewpoint neutral:

Exercise:

- "No protests in the quad about immigration"
- "No one can speak on the quad about their religion, except Christians."

What about Hate Speech?


- There are hate <u>crime</u> laws, which hold that if a crime is committed AND there is evidence that it was motivated by prejudice or bias, additional penalties or harsher sentencing can be applied.
- There is no legal definition of hate speech, and every college/university hate speech code that has been challenged in court has been struck down.
 - Problem: Subjectivity. Who decides what is harmful/hateful/offensive?

Unintended Consequences



An Example: University of Michigan

- During the years Michigan's speech code was on the books (1988-89), more than 20 Black students were charged with racist speech by white students.
- There wasn't a single instance of a white student being punished for racist speech, even though that was what had prompted the drafting of the Michigan speech code in the first place.



What CAN colleges do?

- "The college is saying it can't/won't do anything about harmful or problematic speech"
- Not true: the college can't <u>censor</u> and <u>punish</u> certain speech based on subject matter or viewpoint. However we can do lots of things.

From ACLU:

- speak out loudly and clearly against expressions of racist, sexist, homophobic, and transphobic speech, as well as other instances of discrimination against marginalized individuals or groups;
- react promptly and firmly to counter acts of discriminatory harassment, intimidation, or invasion of privacy;
- create forums and workshops to raise awareness and promote dialogue on issues of race, sex, sexual orientation, and gender identity;
- intensify their efforts to ensure broad diversity among the student body, throughout the faculty, and within the college administration;
- vigilantly defend the equal rights of all speakers and all ideas to be heard, and promote a climate
 of robust and uninhibited dialogue and debate open to all views, no matter how controversial.

Harms and Needs

- What are some of the harms of encountering speech or perspectives that feel offensive or hostile to you?
- What are some of the resulting needs from those harms?
- How can those needs be met?
- What role can student leaders play?

- Bystander Effect- What is it?
- Some elements:
 - Diffusion of responsibility ("someone else will do something")
 - Conformity
 - Ambiguity ("if no one else is saying anything, maybe I shouldn't get involved")


Counter Speech Examples:



Scenarios:

What can the college do? What can students do?

- A group of students deface a "Black Lives Matter" display, by spray painting "Blue Lives Matter" and "All Lives Matter" all over it.
- An off-campus political group sets up a table in the quad with a large sign that says: "Deport Illegal Immigrants. Change My Mind."
- A student group organizes an event with a speaker that has made public statements calling for "Israel to be wiped off the map completely"



ASG and Bias:

What are your thoughts on the ruling? How can we address and minimize bias in our ASG?

- <u>Apodaca v. White</u>. In this case out of California State University—San Marcos, the pro-life organization Students for Life asked the student government for \$500 to host a guest speaker to discuss "Abortion and Human Equality."
- The student government used vague policies to deny the request, but at the same time, it was funneling almost \$300,000 to the Gender Equity Center (which advocates abortion) and the LGBTQA Pride Center. ADF filed a lawsuit on behalf of Nathan Apodaca, the president of the campus chapter of Students for Life.
- In 2019, a district court struck down the university's policy of "back-room deliberations" that led to unequal funding for student groups. California State University—San Marcos then agreed to revise its policies to prevent content-based discrimination and pay over \$240,000 stemming from the lawsuit.
