#### MiraCosta College Leon Baradat Award

Description: The Leon Baradat Faculty Award, established in 2018, is conferred annually upon faculty of MiraCosta College. Leon Baradat was a faculty member in political science at MiraCosta from 1970 to 2003 who was committed to the practice of collegiality, both large scale and small. He was an outstanding teacher who engaged, challenged, and inspired his students. He was also founder and president of the Academic Senate for California Community Colleges.

This award honors outstanding MiraCosta faculty, one fulltime and one associate, annually. These honorees will have a passion for teaching and a dedication to students. They additionally will have demonstrated excellence beyond the classroom in fostering engagement and creating a positive and inclusive campus climate through institutional service. These recipients will be leaders who have contributed to the larger good of the MiraCosta College campus. The award may be received only once during the faculty member's lifetime at MiraCosta College.

Award: Recipients of the annual Baradat Award, one fulltime and one part-time faculty member, each receive a "Gold Star" plaque and a cash award of \$300.

Service Criteria: Winning individuals will be nominated by a peer who will provide evidence of their impact at MiraCosta in the following areas through institutional service:

- 1. Creating an inclusive and supportive campus climate
- 2. Success in engaging various constituencies and resources to work together to advance student success
- 3. Demonstrated leadership in campus, professional and/or student activities which advance student success

Employment Criteria: Fulltime nominees must be current tenured faculty. Associate faculty (classroom and non-classroom) must be currently employed with the District and must have been on contract for six (6) consecutive semesters (fall/spring) or assignment periods.

Application: Nominator(s) must submit the Application Form and a 1-page cover letter, along with the name(s) of the nominator(s), to the chair of the faculty awards committee. Additional supporting evidence, if necessary, can be submitted in the Application Form, including qualitative and/or quantitative data, photos, articles, lists of leadership positions held, and/or lists of events/programs planned/executed. On the application form, there is a 250 word limit per prompt. Submissions that exceed the 250 word limit per prompt will not be considered.

The Academic Senate Faculty Awards Committee processes statewide and local awards to celebrate and honor the work of our faculty. This document provides information and timelines for the various awards that we process.

#### **Fall Semester:**

Statewide Exemplary Program Award
Application Deadline: Early November

The Board of Governors established the Exemplary Program Award in 1991 to recognize outstanding community college programs. The Award is sponsored annually by the Foundation for California Community Colleges. The statewide Academic Senate provides focused themes each year. They also provide exact deadline dates each year. ## **Statewide Hayward Award for Excellence in Education**

Application Deadline: Early December

The Statewide Academic Senate provides the Hayward Award for "Excellence in Education." Sponsored annually by the Foundation for California Community Colleges, this award honors community college full-time and part-time faculty who demonstrate the highest level of commitment to their students, college, and profession.
