MOE will consider whether to authorize teleconferencing meetings pursuant to AB 361 and MiraCosta Academic Senate resolution R. 2-21 (10/1/21), since meeting in person would present imminent risks to the health or safety of attendees. In order to continue to meet under these abbreviated teleconferencing procedures, AB 361 requires a legislative body to make specified findings not later than 30 days after the first teleconferenced meeting and to make those findings every 30 days thereafter. MOE will consider the circumstances of the state of emergency and determine if the emergency continues to directly impact the ability of members to meet safely in person OR if state and local officials have imposed or recommended measures to promote social distancing.

Further, the passage of AB 361 allows for the continuance of conducting meetings remotely.
