 Concerns and benefits of student use of tools such as Discord have been expressed, and committee will discuss what, if any, approach that faculty and/or the college more broadly should take in response.

Committee will finalize three annual goals with taskforces for MOE's focus this year:

- 1. Develop a guide for departmental leadership for enhancing quality online teaching and learning.
- 2. Develop a guide for faculty reference when selecting technologies to use for teaching and learning.
- 3. Draft the core components (goals/objectives/outcomes) for a new 3-year Online Education Plan.

Taskforce members for each goal will be confirmed, and each taskforce will have an opportunity to solicit input from the full committee before separating into breakouts. MOE has no scheduled meetings for November due to holidays, so taskforces should plan meeting times to advance their work.
