Members will provide updates on and discuss next steps for continued and new committee goals. Members will ensure they are assigned at least one of the following:

#### A. Continued Goals

1. Build **online onboarding resources/examples** for departments. (Khan)
2. **Seeking student voice/experience** to further inform committee actions about online learning and teaching, especially regarding DI student groups. (Julius)

4. **Build Hybrid/HyFlex resources**- with a focus on Hyflex. (Khan)

### VIII. AI In Instructional Tools Discussion (Khan/Julius)

Khan will update the committee on current AI features enabled in Canvas and share information on future AI features currently in testing phase, followed by a discussion on faculty use of AI instructional tools such as [AI Grading Assistance in Canvas](#). The Academic Senate is looking to MOE for advice related to two important questions that this tool helps to provoke: (1) How should the college, departments, and faculty decide what new institutionally-supported teaching and learning tools that include AI should be available or not available. (2) When we have AI tools available institutionally or at department levels, or when faculty use non-institutional AI tools for teaching and learning, what principles, boundaries or guidelines do we set on that use?

### IX. Adjournment

On September 13, 2022, California Governor Gavin Newsom signed California Assembly Bill 2449 (AB 2449) into law. This bill changes remote attendance rules under Ralph M. Brown Act's open meeting laws. With an effective date of January 1, 2023, AB 2449 imposes four periods of differing rules on remote access to, and member attendance of, local agency public meetings under the Ralph M. Brown Act (Brown Act). Further, a state of emergency is no longer in effect and so governing bodies will now meet in person with the possibility of approved remote attendance. The public may observe the meeting remotely or in person and offer public comment. A link for remote viewing or calling in is noted on the agenda. Therefore, Academic Senate and its subcommittee meetings will be held in person with a Zoom link available. If you wish to attend a meeting and you have another disability requiring special accommodation(s), please notify the Academic Senate Administrative Assistant at 760-795-6873.
