VII. Update on MiraCosta Online Mentoring (Julius, Davis, Khan)

Julius, Davis, and Khan will provide a brief update to MOE on the reboot of the MiraCosta Online Mentor program. The new MOU provides 400 hours per semester for faculty peer mentors to be compensated, and prioritizes development and offering of voluntary course review and extended professional development offerings in addition to continuing 1-1 on-demand faculty support. A call for mentors received strong response by the 10/7 deadline and activity is beginning.
