#### TEAM CHAIR - Dr. Frank Gornick, Chancellor, West Hills CCD:

Dr. Frank Gornick has been the Chief Executive Officer at West Hills CCD since 1994. Dr. Gornick has served as the past Chair of the Central Valley Higher Education Consortium and as the Governor's appointee for higher education on the California Partnership for the San Joaquin Valley.
