#### VII. BOARD RETREAT

### A. Distance Education Report

Dean of Math and Sciences Carlos Lopez and Director of Online Education Jim Julius presented the annual report on distance education. Notable accomplishments this year include ACCJC approval of the district's substantive change proposal to offer more than fifty percent of course units online for programs, degrees, and certificates; closure of the 2011 Online Education Plan; online-teaching workshops for faculty during flex week; student orientation sessions for online learning; and selection to participate in the Chancellor's Office Online Education Initiative Pilot Program. An online education planning team met in spring 2014 and drafted online education vision and mission statements. Next steps include a new three-year online education plan, improving distance education outcomes, and expanding resources to support quality online education.

#### B. Data Dashboard Presentation

Dean of Institutional Effectiveness Bob Pacheco provided a progress report on the new data dashboard. The measures included in the first iteration were reviewed for board information and input. A hands-on dashboard presentation will be provided for the Board of Trustees at the October 22, 2014, regular meeting.
