#### **BACKGROUND**

Subsequent to the negotiations with the Faculty Assembly that resulted in the 2015–2018 MiraCosta Community College District and Faculty Assembly Agreement, a decision was made to transition the district's course management system from Moodle and Blackboard to Canvas. The district has agreed to allocate funding to support faculty work necessary to transition course material and design components from the Blackboard or Moodle course management systems into the Canvas course management system.

#### **STATUS**

The district and the Faculty Assembly have negotiated the terms and conditions of work to be performed and compensation to be paid, and agreed to a memorandum of understanding.

#### RECOMMENDATION

Ratify Memorandum of Understanding No. 17–02, which will modify the 2015–2018 MiraCosta Community College District and Faculty Assembly Agreement.



# MOU Between the MiraCosta Community College District & MiraCosta Community College District – Faculty Assembly

17-02

This MOU modifies the terms of article D (Compensation) of the MCCD District/Faculty Assembly Agreement.

The District and the Assembly hereby agree that:

- 1. The District shall provide funding equivalent to 1,272 full-time work hours to support faculty work necessary to transition course materials and design components from the Blackboard or Moodle course management systems into the Canvas course management system.
- 2. The District and the Assembly have mutually agreed upon eligibility criteria and compensation amounts to be received by individual faculty members.
- 3. <u>Eligibility Criteria</u>: Only full-time faculty of the District who participated in the Canvas Survey and prepared instructional materials in Blackboard/Moodle on or before December 17, 2016 are eligible to receive compensation under the terms of this agreement. A list of all eligible faculty members is attached hereto as Appendix A.
- 4. <u>Compensation Amount</u>: Faculty members who meet the eligibility criteria above will receive a one-time payment March 31, 2017 for the number of hours approved in Appendix A. The payment will be paid at the faculty member's non-contractual, hourly rate. (C.11.0). The number of approved hours is based upon data collected from the Canvas Survey conducted jointly by representatives of the District and the Assembly in December 2016 and January 2017.
- 5. The transition of course materials into Canvas must be completed by August 20, 2018.

This agreement will become effective upon approval.
