Administrative procedures create a plan of action for achieving board policies. APs are the responsibility of the superintendent/president and do not require board action.

In fall 2008, the MiraCosta Community College District subscribed to the Community College League (CCLC) Policy and Procedure Service in order to update board policies and administrative procedures.
